# MINUTES WILKES COUNTY BOARD OF COMMISSIONERS June 4, 2019

The Wilkes County Board of Commissioners met on Tuesday, June 4, 2019 at 7:01 P.M. with the following members present: Chairman Keith Elmore, Vice Chairman Eddie Settle, Commissioner Gary D. Blevins, Commissioner David Gambill, and Commissioner Brian Minton.

Also present for the meeting were Tony Triplett, County Attorney; John Yates, County Manager; and Sarah Call, Clerk to the Board.

Chairman Keith Elmore welcomed everyone and called the meeting to order.

**INVOCATION** – Commissioner David Gambill led the Invocation.

PLEDGE OF ALLEGIANCE – Chairman Giddeon Keith Elmore led the Pledge of Allegiance.

**APPROVAL OF MINUTES** – Motion was made by Commissioner David Gambill, seconded by Commissioner Gary D. Blevins and unanimously adopted to approve the Minutes of the Board meeting held on May 21, 2019.

BUDGET AMENDMENTS/TRANSFERS – Motion was made by Vice Chairman Eddie Settle to approve Budget Amendment No. 31 (General – Sheriff – The 2017 JAG (\$10,410) has been made available for spending. The Wilkes County Sheriff's Office intends to use this money to purchase the items listed below. Items purchased will better equip this office with handling IED situations. Van Ramp, Night Vision, Weapon Lights, Special Pincer Probes, Tactical Gun Mounts); and Budget Amendment No. 32 (General – DSS Purchase of Care/Private Providers is running under budgeted amount and there is a need to purchase 2 (two) vehicles (\$50,000) because one vehicle is broken and will cost more to fix than the value of the vehicle and the other vehicle has high mileage); and Budget Amendment No. 33 (Health-Programs – Family Planning Wilkes County Health Department received additional funds for the state (\$8,099) for Family Planning. These funds will be used for salaries. No County money involved); and Budget Amendment No. 34 (Fire Districts – General – These Fire Department's collections were higher than projected (\$95,000) in the current budget). The motion was seconded by Commissioner Gary D. Blevins and unanimously approved.

## JUVENILE CRIME PREVENTION COUNCIL (JCPC):

1. JCPC CERTIFICATION STANDARDS FISCAL YEAR 2019-2020 – Chairman Elmore welcomed and recognized Christyn Grant, Chairperson JCPC. Ms. Grant thanked the Board and stated she is here for review and approval of the JCPC Certification Standards for FY 2019-2020.

Motion was made by Commissioner Brian Minton to approve the Juvenile Crime Prevention Council Certification Standards for Fiscal Year 2019-2020 as presented. The motion was seconded by Commissioner Gary D. Blevins and passed unanimously.

Ms. Grant stated the JCPC is also submitting the following recommendations for approval of 2-year term appointments to fill vacancies on the Board created by resignations for the following positions:

Captain Jason Delbert, Wilkesboro Police Department to fill the Chief of Police vacancy created by the resignation of Tommy Rhoades; and Lieutenant Jana Hayes, Wilkes County Sheriff's Department to fill the Local Sheriff or designee vacancy created by the resignation of Logan Kerr.

Commissioner Brian Minton made a motion to Reappoint Scott Perry, Zachary Shepherd, Casey Prim-Shields, Christyn Grant, Bryan McDevitt, Andrew Warren, Jane Casarez, Amy Mastin for 2-year terms and Appoint Captain Jason Delbert, and Lieutenant Jana Hayes to 2-year terms to the Juvenile Crime Prevention Council as requested and presented. The motion was seconded by Commissioner Gary D. Blevins and unanimously approved.

BLUE RIDGE OPPORTUNITY COMMISSION (BROC) – WORLD ELDER ABUSE AWARENESS DAY – PROCLAMATION – Chairman Elmore welcomed and recognized Jennifer Cooper, Director BROC Senior Nutrition Services. Ms. Cooper said BROC as the Lead Agency on Aging in Wilkes are requesting the Board proclaim June 15, 2019 as World Elder Abuse Awareness Day in Wilkes County. She added their hope is to start this year with the proclamation and next year the goal is to organize an event to have more public awareness. Chairman Elmore stated this is the first time they have recognized this. Ms. Copper replied yes. Ms. Cooper read the Proclamation at this time.

Commissioner Brian Minton made a motion to approve the Proclamation to declare June 15, 2019 as World Elder Abuse Awareness Day in Wilkes County and adopt the World Elder Abuse Awareness Day Proclamation as requested and presented. The motion was seconded by Commissioner Gary D. Blevins and unanimously approved.

#### WORLD ELDER ABUSE AWARENESS DAY

WHEREAS: Older adults deserve to be treated with respect and dignity to enable them to serve as leaders, mentors, volunteers and vital participating members of our

communities:

WHEREAS: In 2006, the International Network for the Prevention of Elder Abuse, in

support of the United Nations International Plan of Action, proclaimed a day to recognize the significance of elder abuse as a public health and human

rights issue; and

WHEREAS: 2019 marks the 13th Annual World Elder Abuse Awareness Day. Its recognition

will promote a better understanding of abuse and neglect of older adults; and

WHEREAS: The National Center on Elder Abuse (NCEA) and the Wilkes County Board of

Commissioners recognizes the importance of taking action to raise awareness,

prevent and address elder abuse; and

WHEREAS: As our population lives longer, we are presented with an opportunity to think

about our collective needs and future as a nation; and

WHEREAS: Ageism and social isolation are major causes of elder abuse in the United

States; and

WHEREAS: Recognizing that it is up to all of us, to ensure that proper social structures

exist so people can retain community and societal connections, reducing the

likelihood of abuse; and

WHEREAS: Preventing abuse of older adults through maintaining and improving social

supports like senior centers, human services and transportation will allow everyone to continue to live as independently as possible and contribute to the

life and vibrancy of our communities; and

WHEREAS: Where there is justice there can be no abuse; therefore, NCEA urges

all people to restore justice by honoring older adults.

WHEREAS: Join us in our engaging and empowering movement, and putting an end to

abuse.

THEREFORE We, the Wilkes County Board of Commissioners, do hereby proclaim June 15,

2019 as World Elder Abuse Awareness Day in Wilkes County, and encourage all of our communities to recognize and celebrate older adults and their

ongoing contributions to the success and vitality of our country.

2019-2020 BUDGET ADOPTION — Chairman Giddeon Keith Elmore stated they have had work sessions and public hearings on the proposed budget and asked for comments from the Board. Commissioner Gambill stated the staff has worked hard to get the budget ready and they appreciate all their work. Commissioner Blevins added it is tough every year. Chairman Elmore stated it is a process and no one gets everything they want in the Budget but he hopes there is a consensus. Vice Chairman Settle stated there has been a lot of hard work on this budget and there is going to have to be a lot of work in the upcoming years. Chairman Elmore added it is going to be tight. Vice Chairman Settle said next year there has to be a lot of no's to folks and they will have to turn the school and others down. He added hopefully the fund balance will be better than expected. Commissioner Blevins stated maybe the sales tax will also be better than expected. Commissioner Gambill said he feels confident the fund balance will be better than expected. Vice Chairman Settle stated the EMS stations are not included and he is depending on the Board to stick with this, it will be a positive for the outlying areas of the county. Commissioner Blevins added they are making progress in the right direction. Commissioner Gambill agreed.

There is hereby levied for the fiscal year ending June 30, 2020 a tax rate of sixty-six (\$0.66) cents on each one hundred dollars (\$100.00) assessed valuation of taxable property as listed as of January 1, 2019, for the purpose of raising the revenue from current year's property tax as set forth in the foregoing estimate of revenue, and in order to finance foregoing appropriations.

The tax rate of sixty-six (66) cents per hundred dollars valuation is based on an estimated total appraised value of property for the purpose of taxation of \$5,836,230,713, with estimated collection of 96.00% on real and personal property and 100% on vehicles.

#### **DEPARTMENT OF SOCIAL SERVICES:**

#### 1. MEMORANDUM OF UNDERSTANDING FISCAL YEAR 2019-2020 –

APPROVAL – Chairman Giddeon Keith Elmore recognized and welcomed Department of Social Services Director John Blevins. Mr. Blevins said this agreement began last year with a few changes this year. He added last year the MOU did not have a corrective action plan, in November 2018 it was changed from static measures to growth measures, which is good. The new MOU has to show growth, not meet a target number, which is easier for counties to do. The good news is not all of the programs are included in the corrective action plan as Attachment I sets out. Mr. Blevins said the rest will be monitored, because the state can't validate the data on those programs and tell them what criteria they would have to meet so those are not included. Chairman Elmore asked if this means it could cost them for the plans that are included. Mr. Blevins replied yes eventually. He added Attachment II is the Corrective Action section of the MOU and explained how this would work. There is a process before it gets to that point, there are many steps. Mr. Blevins stated they feel they will meet the criteria set out in the MOU at this time on the programs included.

Vice Chairman Eddie Settle made a motion to approve the Memorandum of Understanding for Fiscal Year 2019-2020 between the North Carolina Department of Health and Human Services and Wilkes County as presented. The motion was seconded by Commissioner Gary D. Blevins and unanimously approved.

2. ENERGY PROGRAMS OUTREACH PLAN – APPROVAL FOR FY 2019-2020 – Mr. Blevins said this is a standard plan for low income energy assistance and crisis fuel assistance programs and there have not been any changes since last year. The plan states they have a committee as listed in the plan and how they will work and get the information out to the

public for people to apply for this assistance and the hours they can apply. Mr. Blevins said for the upcoming fiscal year they will receive \$347,063 for each program included with no county funds. He stated the Outreach Plan must be approved by the local Board and he is requesting approval of the DSS plan for FY 2019-2020. Mr. Blevins said this is a lot of money that comes to Wilkes and helps a lot of people, which is wonderful and they give out all of these funds quickly.

Commissioner Gary D. Blevins made a motion to approve Wilkes County Department of Social Services Energy Programs Outreach Plan for FY 2019-2020 as presented. The motion was seconded by Vice Chairman Eddie Settle and unanimously approved.

**3. UPDATE** – Mr. Blevins provided the Commissioners with handouts for April. He briefly went over the monthly caseload report, Foster Care financial report, Adoption Services financial report, Child Development and Subsidized Child Care financial report. He also went through the CPS Foster Care monthly reports for April.

The Board thanked Mr. Blevins for his update.

#### TAX DEPARTMENT:

PURCHASE OF COUNTY-OWNED PROPERTY – ELK TOWNSHIP – County Attorney Tony Triplett stated this is different as explained in his memo with the background on this matter. This is also a tax foreclosure property, but is an unusual circumstance where the former owner wishes to buy it back. Mr. Triplett said there is a specific statute that covers this, the Board is not required to, but are permitted to sale it back to the original owner. He added they do not need to put it out for upset bids, so long as the offer is at least what the county has in the property. He added Mr. David Nate Whaley, the former owner, explained that he went through a bad financial spell and could not pay the taxes for several years and allowed it be foreclosed on. Now he is back on his feet and would like to buy the property back. Mr. Triplett stated it is vacant property, the county has \$10,432.84 in the property total and he has offered \$10,500. Mr. Triplett said N.C.G.S. §105-376(c) permits the Board to sell it back to him for that price, if the Board wishes to do so.

Chairman Elmore said he is glad Mr. Whaley can now do this and he is happy the Board is allowed the option to do this for him. Commissioner Blevins asked the appraised value or tax value of the property and has there been any attempts to sale it. Mr. Triplett stated the tax value is listed in the memo at \$56,290, there were not bids at the tax foreclosure sale. Commissioner Gambill stated the \$10,432.84 covers all cost. Mr. Triplett replied yes. Commissioner Blevins asked if the Board has ever done this before. Mr. Triplett replied if they have it has been 15 to 20 years ago. Commissioner Gambill stated he would like to allow Mr. Whaley to buy it back

for what the county has in it, everyone has had hard times at some point. Commissioner Blevins said he is not sure this is the right thing to do for the tax payors.
